ARTICLE 8. ENFORCEMENT OF IMMIGRATION LAWS 4

11-1051. Cooperation and assistance in enforcement of 5

immigration laws 6

A. EXCEPT AS PROVIDED IN FEDERAL LAW, OFFICIALS, AGENCIES OR PERSONNEL 7 OF COUNTIES, CITIES AND TOWNS MAY NOT BE PROHIBITED OR IN ANY WAY RESTRICTED 8

FROM SENDING, RECEIVING OR MAINTAINING INFORMATION RELATING TO THE 9 IMMIGRATION STATUS, LAWFUL OR UNLAWFUL, OF ANY INDIVIDUAL OR EXCHANGING THAT 10

INFORMATION WITH ANY OTHER FEDERAL, STATE OR LOCAL GOVERNMENTAL ENTITY FOR 11

THE FOLLOWING OFFICIAL PURPOSES: 12

1. DETERMINATION OF ELIGIBILITY FOR ANY FEDERAL, STATE OR LOCAL PUBLIC 13 BENEFIT, SERVICE OR LICENSE THAT IS RESTRICTED IN WHOLE OR IN PART ON THE 14

BASIS OF IMMIGRATION STATUS. 15

- 2. VERIFICATION OF ANY CLAIM OF LEGAL DOMICILE IF LEGAL DOMICILE IS 16 REQUIRED BY LAW OR CONTRACT. 17
- 3. CONFIRMATION OF THE IDENTITY OF ANY PERSON WHO IS ARRESTED. 18
- B. COUNTY SHERIFFS AND POLICE DEPARTMENTS OF CITIES AND TOWNS SHALL 19 IMPLEMENT A PROGRAM TO ADDRESS VIOLATIONS OF FEDERAL IMMIGRATION LAWS BY 20

TRAINING PEACE OFFICERS OR DETENTION OFFICERS, EMBEDDING UNITED STATES 21

IMMIGRATION AND CUSTOMS ENFORCEMENT AGENTS WITHIN THE AGENCY, OR ESTABLISHING 22

OPERATIONAL RELATIONSHIPS WITH THE UNITED STATES IMMIGRATION AND CUSTOMS 23

ENFORCEMENT TO IMPLEMENT THE PROVISIONS OF THIS SECTION. ANY TRAINING 24 PROVIDED PURSUANT TO THIS SECTION SHALL BE FUNDED BY ANY SOURCE OF FEDERAL 25

FUNDING OR BY THE STATE IF FEDERAL FUNDING IS UNAVAILABLE. PEACE OFFICER AND 26

DETENTION OFFICER TRAINING SHALL BE PROVIDED BY AN AUTHORIZED FEDERAL ENTITY 27

OR AN ENTITY AUTHORIZED BY THE FEDERAL GOVERNMENT TO PROVIDE TRAINING ON 28 FEDERAL IMMIGRATION LAWS. 29
